Dear Presidents and Chancellors:

This is a follow-up, now from 32 expert researchers, to our November 17 letter about the AAU's planned sexual assault survey.

Yesterday, the AAU released a revised advisory board for the Sexual Assault and Campus Climate Survey. The institutions represented (by number of members appointed to the board) are: University of Virginia (4), Yale (3), Brown (3), University of North Carolina (2), Cornell (1), Columbia (1), Harvard (1), MIT (1), University of Wisconsin (1) and COFHE (1).

We were shocked to see that the University of Virginia, under fire for mishandling sexual assault, has the largest number of members of the design team compared to any other school. We were concerned to see the imbalance in geographical and institutional representation. We were particularly dismayed to see that so few scientists with expertise in measuring sexual violence were included on the design team.

We continue to object to a secret survey that researchers cannot scrutinize. Being an AAU team player on this matter means subsidizing a survey that has been criticized as lacking in appropriate scientific expertise and flawed by the short time-frame and lack of transparency mandated by the contract.

We urge you to decline to participate until the AAU has addressed these problems. We invite you to interact with any of us regarding the issues we have raised in this or our previous letter.
